2019 NCBA DII League Participation Agreement – Renewal (Registration NLT July 1, 2018)

This League Participation Agreement (“Agreement”) is by and between the Undersigned College or University Club Baseball Team (“Team”) and the National Club Baseball Association (“NCBA”).

The undersigned Team hereby agrees to participate in the NCBA’s 2018/2019 Division II season upon the terms and conditions contained in this Agreement. The Team agrees that it will adhere to all NCBA DII rules and regulations, including, but not limited to, the payment of the NCBA 2018/2019 DII annual dues in the amount of \$1,850.00, which shall be due and payable no later than February 28, 2019. Annual dues for the 2018/2019 DII season shall be discounted to \$1,750.00 if paid in full by the Team on or before December 31, 2018. The Team understands that the annual dues are non-refundable. Any fees associated with non-payment are the sole responsibility of the (institution/signee etc...)

The team also agrees that it will submit a \$300.00 performance bond to the NCBA prior to Sept 15, 2018*. This performance bond will be returned to the team in full at the conclusion of the 2018/2019 season provided the team has not forfeited any of its NCBA sanctioned games. (See NCBA DII Rule 23.08.0)

The Team further understands that it is responsible for ensuring that all team players individually complete the online NCBA DII Player Registration, and agrees to submit a signed academic eligibility letter for all team players to the NCBA prior to participating in any NCBA sanctioned baseball games.

In consideration of the Team’s agreement to be bound by the terms of this League Participation Agreement and the NCBA DII rules and regulations, the NCBA hereby agrees to provide the following benefits and services to the Team throughout the term of the NCBA 2018/2019 DII season:

- 1) Official recognition as a member of the National Club Baseball Association Division II;
- 2) Scheduling of a regular season conference schedule of games;
- 3) Opportunity to compete for the right to participate in National Postseason play;
- 4) Full access to the Official NCBA website (www.clubbbaseball.org/Div2) for the purpose of tracking rosters, player stats, player bios, team records, conference standings, team website access, and team contact information;
- 5) Participation in the Official NCBA Fundraising Programs;
- 6) Pre-paid delivery of 5 Dozen Official NCBA game balls;
- 7) Pre-paid delivery of 2 BBCOR Certified Baseball Bats;
- 8) Pre-paid delivery of 8 Batting Helmets OR 1 complete set of Catchers Gear;
- 9) Team coverage under an NCBA premium pre-paid general liability insurance policy;
- 10) Participation in the benefits of all Official NCBA Sponsorship programs and
- 11) Opportunity to obtain Official NCBA Consultation on club baseball program management issues.

*Performance bond due ONLY if the 2017-18 performance bond was returned, forfeited, or never paid due to previous DIII status.
